### 1. Discussion of the Results of the Winter Exam Session of the 2023-2024 Academic Year.

The following measures should be implemented during the spring semester:

- The ICT-oriented courses for first-year students should be structured to enhance students' practical knowledge and skills.
- Large capacity auditoriums should be equipped with computers and utilized during the teaching process, as well as for written exams of first-year students.
- The infrastructure of the current exam rooms should be improved.
- The exam module should be improved and aligned with the current ICT capabilities.
- To strengthen control over the exam process, exam rooms should be equipped with cameras, and training on exam regulations should be organized for invigilators.
- The exam questions and tests should be reviewed and improved.

### 2. Report on AzTU's Scientific Research and Innovation Activities in 2023.

- 3. The report by the Vice Rector for Science and Innovation, Professor Sübhan Namazov, on "AzTU's scientific research, scientometric indicators, and innovation activities in 2023" is considered satisfactory.
- 4. Scientometric indicators of faculties and departments should be thoroughly discussed at the faculty, department, and institute levels, and an action plan should be prepared to improve these results.
- 5. All structures should provide necessary support to improve AzTU's position in QS and other ranking tables.
- 6. High-potential staff from the departments should be effectively utilized for the fundamental restructuring of the institutes' scientific research activities.
- 7. The information presented regarding the differential salary system should be approved:
  - According to the current regulations, the salaries of the top 60 faculty members in the ranking list should be increased from January 1, 2024, to December 31, 2024, and the necessary actions should be carried out (with clarifications within 10 days).
  - The results of articles published in international scientific journals (Web of Science and SCOPUS) should be summarized quickly, and proposals for onetime awards for these works should be submitted to the rectorate.
  - The Finance Department should implement necessary actions related to these payments.
- 8. The Research and Development Department should support the activation of AzTU faculty's publication activities in appropriate international scientific journals.
- 9. Activities for including the materials of international conferences organized by AzTU in international scientific databases should be further intensified and positive practices should be applied.
- 10. Initiatives should be implemented by departments and institutes for conducting industry-relevant research.
- 11. Other issues arising from the report and presentations should be summarized, and considered for effective organization of scientific research activities in the next year.

12. The execution of the decision should be supervised by the Vice Rector for Science and Innovation, Sübhan Namazov.

### 13. Application for Academic Titles to the Higher Attestation Commission.

- 1. Strengthening Scientific Research Activities, Including Organizing Scientific Seminars in Specific Areas, and Approval of AzTU's Short- and Medium-Term Strategic Plan for 2024-2030.
  - 1. AzTU's existing scientific potential should be aligned with the university's accepted priority scientific areas and organized by the university's research institutes in coordination with relevant departments.
  - 2. The university's research potential should be evaluated based on the publication of practical, significant articles in indexed journals.
  - 3. Researchers with high research potential should be invited to work full-time or part-time in scientific research institutes with reduced teaching hours.
  - 4. Foreign researchers should be invited to work as research scholars in scientific research institutes for each priority area to enhance research potential.
  - 5. Undergraduate, master's, and doctoral students with research potential should be actively involved in research work, coordinated with YTI (Scientific and Technical Information Center) and relevant departments.
  - 6. For doctoral students, scientific advisors should only be university staff, with foreign scholars allowed to serve as advisors when necessary.
  - 7. Scientific seminars should be organized on priority research topics, and the topics should be discussed in depth by research scientists, foreign partners, doctoral students, master's students, and research-oriented undergraduates, with active participation of government and industry partners.
  - 8. AzTU's short- and medium-term strategic plan for 2024-2030 should be approved.
- 2. Action Plan Regarding the Activities of the "Machine Science" Journal. The action plan for the activities of the "Machine Science" journal should be approved.

- 3. Change of Dissertation Topic for PhD Student Fuad Daşdəmirov in the Department of "Transport Logistics and Traffic Safety." Action Plan for Expanding and Further Developing Collaboration with the National University of Sciences and Technology (NUST) of Pakistan. 1. The defined areas of cooperation between the National University of Sciences and Technology (NUST) of Pakistan and Azerbaijan Technical University should be approved (Appendix attached). 2. To further develop collaboration with NUST, a delegation from AzTU, led by the rector, should visit Pakistan, with relevant specialists selected to be sent for expanding scientific and educational relations. A schedule for the visit should be prepared. 3. Professors and associate professors from Pakistan, especially from NUST, should be invited to AzTU to teach the necessary subjects and specializations. 5. The coordination of the preparation of the industrial prototype, provision of necessary assistance, and the coordination of the preparation process schedule should be discussed and coordinated with the Azercosmos Agency. Discussions should also be held with the Ministry of Defense Industry and the Ministry of Defense to identify partners to support the development and goals of the nanosatellite. 2. Ensuring the Widespread Integration of AzTU Employees with ChatGPT and Other Artificial Intelligence Systems. 1. The use of ChatGPT and other AI systems should be ensured at all levels of AzTU administration, particularly for faculty members and students, in their daily activities. 2. A special incentive group should be formed to expand the involvement of staff in using AI systems.

- 3. The application of AI systems in AzTU's educational and training processes should be expanded and accelerated, and initiatives and creativity in this area should be encouraged.
- 4. The use of AI systems in performing scientific research, conducting relevant compatibilities, comparing results, and preparing reviews should be expanded and accelerated in the departments.
- 5. The IT department should ensure the accessibility of mass and professional usage models, in collaboration with the Financial and Economic Department, and facilitate their implementation.

# 3. Changes in the Curriculum for Modern Engineering Training Through Updating Specialized Courses.

- 1. Starting from the 2024/2025 academic year, elective courses containing modern information technologies such as Artificial Intelligence, Data Analysis, Machine Learning, Internet of Things, Neural Networks, etc., should be included in the curriculum for undergraduate education, and the teaching plans should be approved and organized.
- 2. Faculties, departments, and specialization heads should be tasked with providing their feedback and suggestions on the first point of the decision within 10 working days, agreeing on the curriculum for approval.
- 3. Relevant departments, the AI Institute, and other partner organizations should work together on implementing complex actions to start teaching the new courses from the next academic year.

### 4. Key Indicators and Results of AzTU's Activities in the 2023-2024 Academic Year.

The report on the key indicators and results of AzTU's activities for the 2023-2024 academic year should be considered satisfactory.

## 5. Necessary Actions to Improve AzTU's QS, THE, and Other International Rankings.

- o Institutional accreditation procedures and the selection and application of indicators for international rankings should be carried out. Relevant departments and academic structures should define their duties and ensure the classification and distribution of criteria (KPIs), including initial evaluations and audits.
- Seminars and training sessions should be organized for department heads, faculty members, and relevant staff to adopt methodologies in line with international ranking indicators.
- The knowledge of all teachers involved in the teaching process should be assessed, and certifications should be provided to ensure that the teaching methods remain modern and IT-based. An IT-based teacher training program should be implemented in cooperation with competent institutions for certification. Those who fail to obtain the required certificates should not be involved in the teaching process, in accordance with the legislation.
- A competitive environment should be created to increase productivity in administrative and academic structures, ensuring the quality of training, research, and innovation. Salaries should be structured with a fixed base and variable parts, with the variable portion determined based on measurable criteria, in alignment

- with efficiency indicators. A rule should be developed for determining the variable portion of differential salaries in a competitive environment.
- For enhancing QS and other international rankings, the publication of articles by faculty members in SCOPUS and Web of Science-indexed journals should be monitored:
  - Professors should publish at least 2 articles per year (at least one in Q1 or Q2).
  - Associate professors should publish at least 1 article per year (in Q1 or Q2).
  - Senior lecturers, lecturers, and assistants should publish at least 1 article.
  - PhD students should publish at least 3 articles during their education (at least 1 article in 2 years).
- o Academic staff who are capable of publishing articles in Q1 and Q2 journals should be selected and incentivized as per the legislation. Changes to the methodology for differential salaries for publishing in Q1 and Q2 journals should be included in the agenda of the next Scientific Council meeting.
- o From November 30, 2024, the responsibilities of deans should include supporting IT-based development activities at faculties, in line with new criteria for the position, in accordance with the legislation.
- For the position of faculty dean, special emphasis should be placed on leadership skills, modernity, support for new teaching, research, and innovations, particularly in industry collaboration.

# 6. Institutional and Management Issues Related to the Creation of the Public Legal Entity of Azerbaijan Technical University.

- The Department of International Trade, Logistics, and Marketing should be merged with the Department of Economics and Statistics and renamed the Department of Economics and Statistics.
- o The new structure of Azerbaijan Technical University should be approved (attached).
- o Relevant measures should be taken by the structural divisions, and an order draft and final staffing chart should be prepared, improving management. The preparation of selection criteria, recruitment of new staff, training, and possible reductions in some structures should be carried out from October 1, 2024, over a period of 3 months.

### 7.1. Establishment of the Rector's Special Scholarship at AzTU.

The Rector's Special Scholarship should be awarded to the following students of Azerbaijan Technical University (AzTU) based on the criteria outlined:

- All students who enter the bachelor's program of AzTU with a minimum of 600
  points will receive a monthly scholarship of 200 AZN for the duration of their
  studies.
- The highest-scoring student in each faculty, who enters with a minimum of 500 points, will receive a monthly scholarship of 100 AZN for the duration of their studies.

Note:

- To maintain the scholarship, students must achieve high results throughout their studies.
- The scholarship will be granted starting from the second semester of the first year if the student's overall GPA is 91 or higher.
- The scholarship does not limit other scholarships the student may receive.
- If the GPA falls below 91 during the study period, the scholarship will be revoked
